Smothermon, the undersigned District Attorney of said County, in the name and by the authority, and on behalf of the State of Oklahoma, give information that in said County of Pottawatomie and in the State of Oklahoma, **JAMIE BAKER**, did then and there unlawfully, willfully, knowingly and wrongfully commit the crimes of:

**COUNT 1: RAPE - SECOND DEGREE ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at Mabel Bassett Correctional Center located at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by having sexual intercourse involving vaginal penetration with VICTIM 1, a female person not the wife of the said defendant, said female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections.

**COUNT 2: RAPE - SECOND DEGREE ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at Mabel Bassett Correctional Center located at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by having sexual intercourse involving vaginal penetration with VICTIM 1, a female person not the wife of the said defendant, said female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections.

**COUNT 3: RAPE - SECOND DEGREE ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at Mabel Bassett Correctional Center located at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by having sexual intercourse involving vaginal penetration with VICTIM 1, a female person not the wife of the said defendant, said female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections.

**COUNT 4: RAPE - SECOND DEGREE ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at Mabel Bassett Correctional Center located at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by having sexual intercourse involving vaginal penetration with VICTIM 1, a female person not the wife of the said defendant, said female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections.

**COUNT 5: RAPE - SECOND DEGREE ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at Mabel Bassett Correctional Center located at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by having sexual intercourse involving vaginal penetration with VICTIM 1, a female person not the wife of the said defendant, said female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections.

**COUNT 6: RAPE - SECOND DEGREE ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at Mabel Bassett Correctional Center located at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by having sexual intercourse involving vaginal penetration with VICTIM 1, a female person not the wife of the said defendant, said female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections.

**COUNT 7: SEXUAL BATTERY ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by intentionally touching the breasts and vaginal area of VICTIM 2, in a lewd and lascivious manner and without the consent of VICTIM 2, who is a female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections.

**COUNT 8: RAPE - SECOND DEGREE ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at Mabel Bassett Correctional Center located at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by having sexual intercourse involving vaginal penetration with VICTIM 2, a female person not the wife of the said defendant, said female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody, and under the authority of the Oklahoma Department of Corrections.

**COUNT 9: FORCIBLE SODOMY ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at Mabel Bassett Correctional Center located at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by defendant engaging in penetration of the mouth of VICTIM 3, who was not capable of giving legal consent because being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections.

**COUNT 10: RAPE - FIRST DEGREE (BY FORCE OR FEAR) ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at Mabel Bassett Correctional Center located at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by having sexual intercourse involving vaginal penetration with VICTIM 4, a female person not the wife of the said defendant, said female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections, by using force or fear.

**COUNT 11: RAPE - SECOND DEGREE ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at Mabel Bassett Correctional Center located at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by having sexual intercourse involving vaginal penetration with VICTIM 5, a female person not the wife of the said defendant, said female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections.

**COUNT 12: RAPE - SECOND DEGREE ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at Mabel Bassett Correctional Center located at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by having sexual intercourse involving vaginal penetration with VICTIM 6, a female person not the wife of the said defendant, said female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections.


**COUNT 13: SEXUAL BATTERY ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by intentionally touching and mauling the breasts of VICTIM 7, in a lewd and lascivious manner and without the consent of VICTIM 7, who is a female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections.

**COUNT 14: SEXUAL BATTERY ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by intentionally touching and mauling the breasts of VICTIM 8, in a lewd and lascivious manner and without the consent of VICTIM 8, who is a female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections.

**COUNT 15: SEXUAL BATTERY ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by intentionally touching and mauling the breasts of VICTIM 9, in a lewd and lascivious manner and without the consent of VICTIM 9, who is a female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody and under the authority of the Oklahoma Department of Corrections.

**COUNT 16: RAPE - SECOND DEGREE ~ a FELONY**, on or between the 1<sup>st</sup> day of July, 2012, and the 12<sup>th</sup> day of September, 2012, at Mabel Bassett Correctional Center located at 29501 Kickapoo Road, City of McLoud, Pottawatomie County, State of Oklahoma, Defendant being employed at that time by the Oklahoma Department of Corrections as a corrections officer, by having sexual intercourse involving vaginal penetration with VICTIM 10, a female person not the wife of the said defendant, said female being then and there an inmate at Mabel Bassett Correctional Center and in the legal custody, and under the authority of the Oklahoma Department of Corrections.
