AFFIDAVIT FOR PROBABLE CAUSE OF ARREST

The undersigned, upon oath deposes and states as follows, to-wit:

That the affiant, Agent Randy Knight is employed by the Oklahoma Department of Corrections, Office of Internal Affairs Division, 440 South Houston, Suite 505, Tulsa, Oklahoma 74127-8914. Your affiant has been so employed since January 5, 2004.

That on or about the 8th day of October 2012, Pottawatomie County, Oklahoma, the undersigned further states as follows: On September 11, 2012 Offender [REDACTED] reported witnessing a sexual intercourse act between Offender [REDACTED] and Cadet Jamie Baker on Unit C3, and in the storage closet. Staff interviewed Offender [REDACTED] and [REDACTED] denied the act occurred.

A second witness was interviewed by staff, Offender [REDACTED]. Offender [REDACTED] reported [REDACTED] was disclosing to other offenders that she participated in sexual intercourse with Cadet Baker.

MBCC Warden Millicent Newton-Embry requested an investigation to the Department of Corrections, Chief of Internal Affairs Johnny Blevins. Blevins authorized and assigned Agent Randy Knight to conduct an investigation into the reports offered by the offenders.

Interviews were conducted with Offenders [REDACTED] and [REDACTED]. Agent Knight conducted an interview with Offender [REDACTED] that denied participating in a sexual act with Cadet Baker.

Agent Knight conducted an interview with Cadet Baker. During the interview, Baker admitted to participating in 5 separate sexual intercourse acts with Offender [REDACTED]. And, that the sexual acts were conducted on Unit C3 Control Room area. Baker further admitted to receiving oral sex from [REDACTED] in the Unit C entrance and breezeway bathroom. Baker reported the acts occurred in or around July 2012.

Agent Knight conducted an interview with Offender [REDACTED]. [REDACTED] confirmed the information provided by Baker regarding the sexual acts; however, [REDACTED] admitted that one of the sexual intercourse acts occurred in the Unit C3 storage closet, as reported by Offender [REDACTED].

Additional offenders have reported participating in sexual intercourse acts with Cadet Baker. Offender's [REDACTED], [REDACTED], [REDACTED], [REDACTED] and [REDACTED] have reported participating in one sexual intercourse act each with Baker. Evidence has been submitted to the OSBI regarding [REDACTED].


Offenders [REDACTED], [REDACTED], [REDACTED] and [REDACTED] have reported Cadet Baker sexually assaulted them by touching their breasts on one occasion each in 2012.

Regarding Sergeant Richard DeHaven, during the investigation Cadet Jamie Baker provided information that suggested DeHaven introduced contraband to an offender. Offender [REDACTED] reported DeHaven introduced a pack of Top tobacco on one occasion. DeHaven was interviewed and denied introducing contraband; however, admitted to touching or fondling the breasts of Offender [REDACTED]. [REDACTED] was interviewed and confirmed DeHaven's report.

Based on the above noted information, the undersigned requests that a warrant issue for the arrest of **Jamie Baker** for the crimes of Title 21, Section 888 Forcible Sodomy, (1) count and Section 1111 Rape (5) counts.

Based on the above noted information, the undersigned requests that a warrant issue for the arrest **Richard DeHaven** for the crime of Title 21, Section 1123B Sexual Battery (1) count.

The undersigned swears and affirms that the above information is true and correct.
